At a regular meeting of the Alanson Village Council held in the Village Hall located at 7631 US 31, N., Alanson, Michigan, on March 14th, 2022.

The following resolution was made by David Stepanovich and seconded by Doug Larson, to-wit:

Recitals

WHEREAS, the Plat entitled "Map of Riverside Park" is located in the Village of Alanson, Emmet County, Michigan;

WHEREAS, Mark Raymond Fairbairn has requested the Village of Alanson to vacate the following described streets and alleys, or portions of streets and alleys, within the Plat entitled "Map of Riverside Park":

- (1) Spruce St. north of Pine St., within Block 1;
- (2) Birch St. in its entirety, within Block 4;
- (3) Elm St. from the shore of the Crooked River to the western boundary of the western-most alley in Block 3, within Block 1 and Block 4;
- (4) The two (2) alleys within Block 3 north of Pine St; and
- (5) The alley within Block 4 north of Pine St.

WHEREAS, Section 226 of the Land Division Act, being MCL 560.226, requires the Village Council to adopt a resolution consenting to the vacation of the above described streets and alleys within the Plat entitled "Map of Riverside Park" prior to the entry of an order by the Circuit Court vacating those streets and alleys; and

WHEREAS, this Resolution is intended to fulfill the Village's statutory duty under Section 226 of the Land Division Act.

NOW, THEREFORE, BE IT RESOLVED that the Alanson Village Council hereby consents to the vacation of the following described streets and alleys, or portions of streets and alleys, within the Plat entitled "Map of Riverside Park":

- (1) Spruce St. north of Pine St., within Block 1;
- (2) Birch St. in its entirety, within Block 4;
- (3) Elm St. from the shore of the Crooked River to the western boundary of the western-most alley in Block 3, within Block 1 and Block 4;
- (4) The two (2) alleys within Block 3 north of Pine St; and
- (5) The alley within Block 4 north of Pine St.
